Ms. Belch reports the monthly revenue is \$93,873,63 and monthly expenses are \$69,582.63. year to date revenue is \$769,736.28 and expenses are \$877,143.10 a loss of 107,406.82. The end of month cash balance is \$826,552.97. Ms. Belch will investigate the tank maintenance not budgeted for this month. Ms. Belch would like the board to table the treasurer's report since Mr. Taylor wasn't present. Mr. St. Germain made a motion to table the treasure's report. Mr. Parks seconded the motion. Motion tabled.

6. On-Site Manager's Report for February 2024

Good morning! Mr. Cooper reports the delinquent total amount is \$376.00 and \$3881.95 is the total bills due.

Mr. Cooper reports check reader is installed from National Bank of Arizona. Mr. Morehead has been busy with summer turn-ons. Pumped water totaled 1,264,514, customers water 904,817, leak water totaled 300,000, and unaccountable totaled 59,695. The percentage for the month is 4.72% and for the year is 3.11%.
